Sealed proposals for Clemstone Addition / Red Rock Acres Storm Drainage Improvements project, located along Flint Street and Ironstone Circle in these subdivisions, approximately 1200' north of Highway 92 in Platte County, will be received from qualified bidders at the office of the County Clerk, 415 Third Street, Platte City, Missouri, until **August 8, 2019 at 3:00 P.M.** Bids will be publicly opened and read in the County Clerk's Office. Bids received after the designated closing time will be returned unopened.

All proposals shall be made on a printed proposal form as provided in the Project Manual. Each bidder shall enclose TWO complete original (identical) proposals in a sealed envelope, addressed to the "County Clerk, Platte County, Missouri," and marked "Clemstone Addition / Red Rock Acres Storm Drainage Improvements".

The project consists of construction survey staking, constructing a 87 foot long 12' x 5' reinforced concrete box (RCB) culvert, 55 foot long 8' x 5' RCB, 170 foot long 8' x 4' RCB, 142 foot long Double 5' x 3' RCB, concrete headwalls and wingwalls, 4 curb inlets, 32 L.F. of 15" RCP, 56 L.F. of 60" CMP, 2 – 4' diameter sanitary sewer manholes, 43 L.F. of 8" PVC sanitary sewer pipe, concrete driveway slab over drainage pipes, 200 L.F. of concrete curb and gutter, 100 L.F. of asphaltic concrete pavement replacement, 800 foot long gravel access road, grading, riprap blanket, native seeding, sodding and other general construction items.

This project requires compliance with the provisions of the State of Missouri Prevailing Wage Law, regarding labor standards. The selected bidder agrees to abide by prevailing wage law for Platte County and the State of Missouri, and to compensate for work according to the current Annual Wage Order.

The bidder to whom the Contract for the Work is awarded will be required to furnish performance and payment bonds acceptable to the County, each in amount of one hundred percent (100%) of the Contract, in conformity with the requirements of the proposed Contract Documents. An agent authorized to do business in Missouri shall write each bond.

The County reserves the right to reject any or all bids for any reason or to waive any informality in the bidding. Proposals may be held by the County for a period not to exceed sixty (60) days from the date of the opening of the bids for the purpose of reviewing the bids and investigation of the qualifications of the bidder prior to the awarding of the Couract.
